

PAC-12 TOURNAMENT TRIP PROMOTION OFFICIAL RULES

Important: Please read these rules before entering this Promotion (the “Promotion”).
By participating in this Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION. STANDARD MOBILE DEVICE DATA RATES MAY APPLY.

Promotion void where prohibited by law. Subject to all federal, state, and local laws, regulations, and ordinances.

1. Eligibility: The Promotion is open only to legal U.S. residents currently residing in the 50 United States or District of Columbia, who are at least 18 years old (or the age of the majority in their state of jurisdiction, whichever is older). All entries must be received during the Promotion Period and otherwise comply with these Official Rules to be eligible to win a prize. Sponsor’s computer is the official time-keeping device for the Promotion.

Any attempts to obtain additional entries through multiple or duplicate accounts will result in disqualification. **YOU MAY INCUR STANDARD TEXT AND DATA RATES FROM YOUR WIRELESS CARRIER THROUGH ACTIONS TAKEN ENTERING THE PROMOTION. CHECK WITH YOUR WIRELESS SERVICE PROVIDER FOR DETAILS ON ANY APPLICABLE CHARGES. PARTICIPANTS ARE SOLELY RESPONSIBLE FOR ANY SUCH WIRELESS CHARGES.**

4. Identity of Entrant: All actions taken must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including, for example, entries made using any script, macro, bot, or Promotion service). Multiple participants are not permitted to share the same mobile device.

In the event of a dispute about the identity of the entrant, entries made will be declared made by the authorized account holder of the e-mail address submitted at time of entry. An “**authorized account holder**” means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business or educational institution) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
